NEW BUSINESS

Executive Director Garrett asked Ms. Brooks to update the Board on the December happenings.

Ms. Brooks stated that a Christmas Party was held on December 19, 2018 for the Senior Residents of Trenton Housing Authority, not just the Senior Buildings). Approximately 85 Seniors attended, and they had a fantastic time. On December 20th, a party was held for the children of the Afterschool program and each child received a nice gift from Santa. Hot food was also provided. There was another party held at Prospect Village for children who attend the Afterschool program there. We were able to do this through the monies received from the HEPA grant.

REPORT FROM THE CHAIR

Chairwoman Weldon stated that we needed to choose the Committees and explained that the Committees would bring the information back to the Board.

Prior to Public Comment Director Garrett, stated that as of the end of December our Occupancy Rate was 95% and we anticipate that we will reach our goal of 97% occupancy by April 30 2019. To accomplish this, we will need 28 more move-ins than move-outs.

REAC Inspections are scheduled for February 14th and 15th at Wilson Homes. All sites will be inspected this year. The inspection in February was supposed to be completed in April and May of 2018.

PUBLIC COMMENT

Ms. Oliver, 247 Old Rose Street, stated that the light on her front porch is still out. Stated she was told that water is getting in the light. She said it is so dark out there at night you can't even go out the door. She asked when we will be painting the units. Director Garrett explained that we are putting out an IFB to paint the occupied units.
