Commissioner Raines stated that there are 7 individuals with their own opinions. "It is very frustrating when commissioners try to take their own opinion and apply it to everyone on this Board. I want this on the record so when Commissioner Garrette gets back she can read this. She does not speak for me. If she had questions, she would know that we get an occupancy report and she can see how many people are going to court. All of us have called Truelove for one thing or another and those calls are billable hours to an attorney".

Commissioner Gentry stated that he agreed with Commissioner Raines but wanted to add that as a Board, it is the Chair's responsibility to move the meeting forward. "You're here for the bullet points not all of the side conversation and irrelevant stuff. A Commissioner should not be able to take a topic and run the meeting away with it. At some point enough is enough. Yes, a commissioner is entitled to their opinion but after that you need to call for a vote and move it along. Two-hour meetings to me is over the top. It is something that could have been accomplished in an hour or an hour and fifteen minutes"

Commissioner Weldon stated that there is an Agenda for a reason. "We constantly get away from the agenda, everyone speaks out of turn, and we get off topic. We need to stick to the agenda."

Chairman Anderson stated that he would speak with the Secretary and the Attorney to address the matter.

Commissioner Raines stated this is being recorded and that at the next meeting the Chair needs to address it. It is not the responsibility of the Secretary or the Attorney to address it.

Chairman Anderson called for a motion to adjourn the meeting.
