#### **PUBLIC COMMENTS**

Reyon Eutsey, Donnelly Homes, spoke on the quality of the appliances being used in the units and the conditions of her unit as well as outsiders using the hallway as a public restroom. She also had questions regarding transfer process.

Kenneth Hill, French Towers, asked what Security is supposed to do if someone is stuck on the elevator. He stated that he was stuck in the elevator for over a half hour. He called Security and they did nothing. Jelani B. Garrett, Executive Director/Secretary informed Mr. Hill that there is an emergency button in the elevator that goes directly to the fire department.

Commissioner Anderson - thanked the team for the outstanding job they are doing. He is looking forward to making these programs a success.

Commissioner Green - No comment

Commissioner Garrette – Asked for the REAC reports and about the relocation plan. She stated that the report given by Mr. Godfrey during the Secretary's report didn't give much detail. She is not trying to come across negative, but the point she is trying to make is that she is interacting with the residents and the whole objective of being on this non-paying Board is to advocate for the them and they want more information and better communication. From what is being shared the residents are just getting bits and pieces, they are asking for more information on Donnelly Homes, exactly where you are with it. She knows this is a small number of tenants attending this meeting overall; they want more information; she doesn't know if they want to do a special session and try to get them more involved outside of this Board meeting. She recommended that the Tenant Council request that the Director of Security and Maintenance be in attendance so they can answer some of the questions. She also asked Mr. Glover, Director of Security if you could find out who the Police Liaison for both North Trenton and West Trenton.

Commissioner Raines – once again Trenton Housing Authority participated in the Mercer County Summer Youth Jobs Connection program. They accepted 7 interns to work during the summer and provided them with a positive work experience.

Commissioner Weldon – residents need to know the protocol of the job that needs to be done while you are living here at the Housing Authority. Each tenant is provided a lease that they sign so they know what they signed on for. Residents don't put in work orders because they don't want people in their house.

They know they have issues but don't want to report it. The Housing Authority can only do what is allowed of them if they know what the issues are. If they do not know what the issues are there is nothing they can do.
